

**CITY OF MAYFIELD HEIGHTS  
SPECIAL COUNCIL MEETING MINUTES  
January 6, 2016**

The special meeting of Council was called to order at 7:00 P.M. by Mayor Anthony DiCicco.

The Pledge of Allegiance was said.

The purpose of the meeting was to elect a Council President, a Council President Pro Tem, a Council representative to the Planning Commission, and a Council representative to the Mayfield Union Cemetery Board of Trustees. There are also other appointments, which will be made later. Council committee appointments will also need to be made by the Council President.

Mayor DiCicco asked for nominations for Council President. Mrs. Finney nominated Mrs. Teresi. Mayor DiCicco asked for any other nominations, but there were none.

Mr. Manno, seconded by Mrs. Snider, moved to close the nominations and cast a unanimous ballot. Roll Call on motion as stated: AYES: Manno, Mercurio, DeJohn, Sabetta, Finney, Snider, Teresi. NAYS: None. Motion carried.

Gayle Teresi was elected Council President for a two-year term, commencing January 1, 2016 and ending December 31, 2017.

Mayor DiCicco asked for nominations for Council President Pro Tem. Mrs. Teresi nominated Mr. Mercurio. Mayor DiCicco asked for any other nominations, but there were none.

Mrs. Snider, seconded by Mr. Manno, moved to close the nominations and cast a unanimous ballot. Roll Call on motion as stated: AYES: DeJohn, Snider, Sciria, Mercurio, Manno, Sabetta, Teresi. NAYS: None. Motion carried.

Joseph Mercurio was elected Council President Pro Tem for a two-year term, commencing January 1, 2016 and ending December 31, 2017.

Mayor DiCicco asked for nominations for a Representative to the Planning Commission. Mr. Mercurio nominated Mr. DeJohn. Mayor DiCicco asked for any other nominations, but there were none.

Mr. Manno, seconded by Mrs. Teresi, moved to close the nominations and cast a unanimous ballot. Roll Call on motion as stated: AYES: Finney, Sabetta, Snider, Manno, DeJohn, Mercurio, Teresi. NAYS: None. Motion carried.

Robert DeJohn was elected representative to the Planning Commission for a two-year term, commencing January 1, 2016 and ending December 31, 2017.

Mayor DiCicco asked for nominations for a Representative to the Mayfield Union Cemetery Board of Trustees. Mrs. Teresi nominated Mrs. Finney. Mayor DiCicco asked for any other nominations, but there were none.

Mr. Mercurio, seconded by Mrs. Snider, moved to close the nominations and cast a unanimous ballot. Roll Call on motion as stated: AYES: Mercurio, Finney, Sabetta, DeJohn, Snider, Manno, Teresi. NAYS: None. Motion carried.

Donna Finney was elected representative to the Mayfield Union Cemetery Board of Trustees for a two-year term, commencing January 1, 2016 and ending December 31, 2017.
